New Business

6:30 PM Appeal No. 2004-024 Brigida

Ann C. Brigida applied for and was granted a Comprehensive Permit under Chapter 40B of the General Laws of the Commonwealth of Massachusetts, and in accordance with Article II of Chapter Nine of the Code of the Town of Barnstable. Ann C. Brigida no longer wishes to participate in the program and therefore Comprehensive Permit No. 2004-024 must be rescinded. The subject property is addressed as 26 Circuit Avenue, Hyannis, MA as shown on Assessor's Map 324 as Parcel 111. It is zoned Residence B (RB).

Comprehensive Permit Number 2004 - 24 was issued to the applicant on February 25, 2004 and a Regulatory Agreement and Declaration of Restricted Covenants were recorded at the Barnstable County Registry of Deeds on May 28, 2004 in Book 18654, Page 101.

The Applicant no longer wants to participate in the Accessory Affordable Apartment Program and therefore the Comprehensive Permit No. 2004-24 must be rescinded.

A public hearing to rescind Comprehensive Permit No. 2004-24 was duly advertised and notice sent to abutters and the property owner all in accordance with MGL Chapter 40A. The hearing was opened on (today) September 27, 2023 at which time the Hearing Officer, Jacob Dewey, made the following findings and decision:

Findings of Fact:

- 1. The Applicant, Ann C. Brigida, was granted Comprehensive Permit 2004-24 for an Accessory Affordable Apartment at 26 Circuit Ave, Hyannis, MA.
- 2. The applicant, Ann C. Brigida, no longer wants to participate in the Accessory Affordable Apartment Program.
- 3. On August 31, 2023, the Accessory Apartment Program Coordinator took action to rescind Comprehensive Permit No. 2004-24.

Ordered:

Comprehensive Permit number 2004-24 is rescinded.

A written copy of this decision shall be forwarded to the Zoning Board of Appeal as required by the Town of Barnstable Administrative Code Chapter 241, section 11. If after fourteen (14) days from that transmittal the Members of the Zoning Board of Appeals takes no action to reverse the decision, this decision shall become final and a copy shall be the filed in the office of the Town Clerk.

Appeals of the final decision, if any, shall be made to the Barnstable Superior Court pursuant to MGL Chapter 40A, Section 17, within twenty (20) days after the date of the filing of this decision in the office of the Town Clerk. The applicant has the right to appeal this decision as outlined in MGL Chapter 40B, Section 22.
