IN0711-01 – Approve assignment of Silvia & Silvia Lease I & II to Davenport Realty Trust

<u>IN0711-02 – Approve Amendment No. 2 to the Cape Flight Instruction, Inc. Lease to add provisions for Sub-lessee</u>

This item has been removed as the arrangements with the proposed sub-tenant have ceased.

IN0711-03 – Approve Revised AMA/Marine Lumber Revised Lease Fencing Plan

- Kyle Crowley, Aero Management, showed the current and proposed fence lines on a map.
- Currently Aero Management supply trucks are operating in the AOA to deliver to the lumber yard. All operators need badging and training.
- There are currently three access points to the AOA form Aero Management.
- Aero Management proposed to move the fence line to limit access points to the AOA from three down to one, and to be able to operate outside the AOA.
- Aero Management proposed to remove some trees and construct an access road for BMA operations in the vicinity. 1400 feet of new fencing will be erected.

- This proposed fence line change must be approved by the TSA as it is a permanent change to the fencing.
- Management stated that the N1 Gate must be designed to eventually have a striker for a card reader for future accessibility, and a plan must be provided to Ms. Lounsbury, Noise Abatement/Security Specialist.

Action: The subcommittee arrived at a consensus to approve this agenda item.
