II REQUESTS FOR DETERMINATION

Barri & G. Christopher Blauvelt. Seek approval to maintain completed vista pruning at 571 Old Post Rd., Cotuit as shown on Assessor's Map 054 Parcel 018. **DA-12056**

A motion was made to issue a negative determination.

Brian Doyle. Construct deck 16' x 30' 4" with associated stairs; erect fence 36" high 160' around property at 112 Dumont Dr., Hyannis as shown on Assessor's Map 307 Parcel 093. **DA-12057**
