#### I REQUESTS FOR DETERMINATION

**Joanne S. Hynes.** Renovation, removal and replacement of landscape plantings; removal of invasives in easement (for 324 Bridge St.), at 312 & 324 Bridge St., and 22 Great Bay Rd., Osterville as shown on Assessors Map 093 Parcels 017, 018 and 019. **DA-15040** 

The applicant was represented by Arlene Wilson, P.W.S., of A. W. Wilson Associates.

A motion was made to issue a negative determination.

Seconded and voted unanimously.

**Dawn & Gary Burkhead.** Expand existing terraces; replace existing wood timber retaining wall with new fieldstone retaining wall; new walkway from terraces to North Bay Road; expand existing cobblestone driveway apron; repave driveway at 27 North Bay Rd., Osterville as shown on Assessor's Map 072 Parcel 022. **DA-15041** 

The applicant was represented by Peter White of Zen Associates, Inc.

A motion was made to issue a negative determination.

**Patricia Bradley.** Treat and remove phragmites growing on property at 15 Cross Way, W. Hyannisport as shown on Assessor's Map 245 Parcel 042. **SE3-5314** 

The applicant was represented by Steven Wilson, P.E., of Baxter Nye Associates.

A motion was made to continue the hearing to September 29<sup>th</sup>, to allow the applicant to re-notify abutters and to seek approval for additional invasive species removal, with re-planting with native species.

Michael D. & Susan L. White. Construct pool and patio at 577 Sea View Ave., Osterville as shown on Map 114 Parcel 050. SE3-5313
