**A.** Laurie Prothero Sperry. Failed septic system upgrade at 43 Locust Avenue, West Barnstable as shown on Assessor's Map 197 Parcel 027. DA-24003

The applicant was represented by Darren Meyer of Meyer & Sons, Inc.

**B.** The Beach Club. To extend the fence along the property line at 27 Long Beach Road, Centerville as shown on Assessor's Map 206 Parcel 016. **DA-24004** 

The applicant was represented by James Galvano, Manager of The Beach Club.

Issues discussed:

- The fence is approximately 125' long.
- The resource is flood zone and beach area.
- A 6" clearance at the bottom would be hard to maintain with the blowing of the sand.
- An exception will be made in this case for the clearance.

**C. Dewey Gardens LLC.** Vista pruning of bank between lawn and Cotuit Bay at 621 Old Post Road, Cotuit as shown on Assessor's Map 054 Parcel 015-001. **DA-24005** 

The applicant was represented by Dan Dewey of Dewey Gardens.

Issues discussed:

- The request is standard and within the vista pruning guidelines.
- Cut branches less than 3" in diameter will be left on site for the benefit of the resource area because of the steepness of the slope to provide some structure to the bank.

Public comment:

Sara Molyneaux – abutter at 581 Old Post Road. They are in full support of the project.

**D.** Anthony Ambrogio & Anca Viasopolos. Removal of oak saplings and invasive species. Removal of dug in timbers. Planting of native species in disturbed areas at 580 Lumbert Mill Road, Centerville as shown on Assessor's Map 147 Parcel 086. **DA-24006** 

The application was withdrawn.

**A. B. Francis, II & Patricia E. Saul.** Proposed removal of invasive species and replacement with native plantings at 355 Eel River Road, Osterville as shown on Assessor's Map 114 Parcel 023. **SE3-6154** 

The applicant was represented by John O'Dea, P.E. of Sullivan Engineering and Consulting.

Issues discussed:

- For the stability of the bank, the area should be allowed to grow naturally. It will not be a managed area.
- The one-gallon barberry are fine, they will grow bigger but more than 25 plants may be needed.
- Monitoring reports should be submitted.
- More plants could be put in after a couple of years if needed.
- No mulch should be put in.
- The work area is upland of the salt marsh, so a CERP is not required.
- The work area should have erosion control.
- Peter Hanson is the contractor for the job. Conservation staff will need to be notified if there is a change, and the change in contractor must be approved.

Public comment: None

A motion was made to approve the project subject to receipt of annual reports being submitted for 3 years, Peter Hanson will be the contractor, written notification and approval by staff if there is a change in contractor, contractor will install the erosion control above the salt marsh area to minimize any soil disturbance, and if after review more planting needs to be done to stabilize the bank after year 2 or 3, the applicant will be open to that request.
