## BARNSTABLE DISABILITY COMMISSION MINUTES MAY 21, 2008

Meeting called to order at 12:05

<u>Report</u>: Tom Lynch informed the commissioners that one goal of the town is to improve communication with citizenry. For example, @ 5:30 on Channel 18 there will be a webcast on internet highlighting town news from the 44 boards and commissions that exist within the town. If BDC wants a topic covered with advance notice, can be done. Also Mr. Lynch mentioned numerous projects related to access and accessibility for town citizen's and visitors. The Local Comprehensive Plan now includes "visibility" factor such as making developers more aware of ADA/AAB regulations and requirements such as wider doorways etc.

The Shriver family (Foundation for Best Buddies) purchased property across from Craigville Beach for use with/by individuals with disabilities.

Surveys show ARTS and CULTURE are the primary responses given when citizens are asked to rank items. The town is planning to produce educational videos across all departments in the future to educate people about the town and access issues. Mr. Lynch is working with all staff to raise awareness and compliance. e.g. to improve signage in the town
