Meeting called to order at 4:30pm

Notice of Intent to File a Permit to Demolish:

Pursuant to Chapter 112, § 3D of the Town of Barnstable Code, the BHC will determine whether the structure proposed for demolition is a Significant Building in accordance with the Definition set forth in Chapter 112, § 2.

Singh, Ajay & Ritu, 63 Warren Street, Osterville, Map 139, Parcel 076

Built 1930, Not Inventoried, Not in a National Register District

Proposed Addition

Represented by Joao Junqugina, Capewide Enterprises, LLC

Mr. Junqugina informed the Commission that the homeowners propose an addition to connect to the existing structure which will involve taking a part of the side wall to cut an entranceway. The second floor window will become an entranceway, as well. The plans that were submitted with the Application were reviewed. (Exhibit A) Nancy Clark commented that the addition appears to be double the size of the existing house and noted that it is a shame that the details of the proposed addition are not matching the design of the oval doors on the existing. Mr. Junqugina stated that he will relay this comment to the homeowners. Chair Grassetti informed Commissioners that she and Growth Management staff have determined that the garage, which is in disrepair, is not significant, and it is slated for demolition. She added that the existing structure has been significantly altered over the years.

Motion duly made by Nancy Clark, seconded by Ted Wurzburg, that in accordance with Chapter 112 § 3D, the Barnstable Historical Commission DOES NOT find that the portion of the building to be demolished at 63 Warren Street, Osterville, is a significant building in accordance with the Definition in Chapter 112 § 2B.

O'Neil, Kevin & Nancy, 61 Strawberry Hill Road, Centerville, Map 246, Parcel 039

Built 1871, Not Inventoried, Not in a National Register District

Demolish Single Family Home (Exhibit B)

Represented by Kevin O'Neil

Mr. O'Neil reminded Commissioners of his earlier appearance approximately nine months ago to seek demolition of a portion of the building, while hoping to renovate the remaining structure. He began the work with a building permit knowing that it would be a challenge. In reviewing the work, the Building Inspector determined that the building needed to be brought up to code or demolished. He was instructed to board up the structure and make it safe. He is now seeking to demolish as he does not have the resources to bring the building up to today's current code.

Nancy Clark noted that this structure was built in 1871 and that in itself is significant to her and it is part of this Commission's job to protect these buildings for the community. Mr. O'Neil stated that it was his intention to restore the building, and he would still like to do so if the building code could accommodate it.

Motion duly made by Nancy Clark, seconded by Marilyn Fifield, that in accordance with Chapter 112 § 3D, the Barnstable Historical Commission DOES find that the building to be demolished at 61 Strawberry Hill Road, Centerville, is a significant building in accordance with the Definition in Chapter 112 § 2B.

Motion duly made by Nancy Clark, seconded by Marilyn Fifield, to refer the building intended to be demolished at 61 Strawberry Hill Road, Centerville, to a Public Hearing to determine how Chapter 112 applies to this structure. The Public Hearing will be duly advertised and noticed for May 21, 2013 at 4:00pm.

In accordance with Chapter 112 § 3E, the applicant is required to maintain a notice of the hearing on the building visible from the nearest public way.

DISCUSSION

Historical Commission Website Update

She is looking to the Commission for suggestions on the scope of information they would like to include. Letter from EBI Consulting dated 3/12/2013 seeking comments related to proposed project's potential effect to historic properties – 414 Main Street, Cotuit – telecommunications facility installation
