Replace Decking, Railing and Stair Treads

Mr. Swetish detailed the proposed replacement of existing railings stair treads and decking with azek material. The decking is located below grade level. William Cronin added that he was out to the site and the stairs are very dangerous as the steps are all rotted. Marina Atsalis asked if the height of the railing will remain the same and Mr. Swetish noted that the railing has to be 42" by building code and the existing is approximately 30-35" so it will be a bit higher. George Jessop asked applicant to check with the building department if he intends to wrap/box the railings as it is his understanding that the structure needs to be visible if it also is an egress. Mr. Swetish indicated that the rails will be PVC material. Mr. Swetish also wished to inform the Commission that the decking color has been changed to ivory instead of the grey originally submitted.
