Repair/Restoration/Preservation of School Administration Building: Replace windows; repairs to damaged brick; re-point brick; roof repair and/or replacement; add new snow guards; replace copper ridges, valleys, finials, crickets and roof flashing; rebuild/replace portions of damaged wall on addition; paint soffits and louvers; insulated metal doors, painted white

- Application reviewed 1; all facets of repairs reviewed
- Roof: approximately 10% of slate to be salvaged and utilized for spot roof repairs

Represented by Steven A. Watchorn of CBI Consulting and Mark Marinaccio of TOB, DPW

- Should funds allow: repairs will include full roof replacement an installation of windows where bricked up
- Window work will include infill on three windows
- Fire escape stairwell to be repositioned to face the town green
