Michelle Massaad replies, the tent will be on the left side, next to green building, alongside the building, there will be two of them next to each other.

Chair Cheryl Powell clarifies that this is the same type of tent to be used that is in the picture?

Jack Kay asks how long will all be up?

Michelle Massaad replies, Sept. 1st and then will take all down. This is the exact same tent that we will be using.

Betsy Young comments that it looks great, it is sunny here and will need a tent, fence looks good, good idea. In favor.

Cecelia Carey has been there, thinks big improvement, a welcome, and the tents serve a primary function for the use. In favor.

Chair Cheryl Powell asks how far off of the sidewalk will this be?

Michelle Massaad replies that there was an existing white fence in front, they will be 6 ft. behind this fence, this if about 6 ft. from the sidewalk also, so about 12 ft.

Antonio Vera- Medina in attendance. He gives an explanation of the business, a French Belgium café, pastries etc. Existing sign, would like to replace with his business sign, Exhibit B, pictures of sign. Top sign will have name of company, bottom sign will be explanation of what we are, what kind of food/business. Signs are PVC with digital print, laminate applied, colors are to be gold lettering and burgundy color.

Jack Kay asks if illuminated?

Antonio Vera- Median replies, yes - existing, same as previous tenant.

Betsy Young asks about the previous sign, that shows picture of cold brew, is this old?

Antonio Vera- Median replies, the old business, not for his.

Chair Cheryl Powell recalls that this color is acceptable color. Staff confirms.

Antonio Vera- Medina would also like to have tables and chairs, aluminum, rust resistant, Exhibit C, picture of proposed chairs and tables. And umbrellas, to follow the red color of the brand on the signage.

Jack Kay asks about the plot plan, didn't see any property lines, how close to the edge?

Antonio Vera-Medina replies that the patio is on private property, not on the sidewalk, right side of the signs, there is an existing patio there. Google map picture of the building shown, Exhibit D.

Chair Cheryl Powell asks if anyone here for Matters not anticipated by the Chair.

Discussion and possible decisions regarding extending HHDC light ending of requirements beyond previously discussed and agreed deadline (Reference: May 20, 2020, meeting)

Chair Cheryl Powell gives a history review about last year and the Take Out signs that were on Main Street. Had discussed with Staff at May 20, 2020, meeting. Didn't want people to have to come and wait for approval of these during this COVID 19 pandemic. Went over some items/agreement for temporary items. These would expire at the end of Phase IV or the state of emergency. This did work out alright. Had an extension. Now the end of state of emergency is here and some things are still there. Some pictures shown, Exhibit D, asks how the Commissioners/people feel about things. Concrete barriers are up, complaints. Do we want to extend?

Betsy Young is not sure what we are extending, nothing in our materials/packet, doesn't remember what it was a year ago. Is this something that is already extended from the state of emergency. Governor has done through the fall November 29th. Are we doing additional?

Chair Cheryl Powell wanted to address because our temporary items had said until Phase IV or the end of the state of emergency, do we want to make official, put something until the Governor lifts it? We are right now beyond timing of what was agreed out of what was put down on paper.

Betsy Young thinks we should go by what Governor says.

David Sorensen is in favor to have until the end of the year. Make some regulations last a little longer.

Chair Cheryl Powell would probably like to go by what the Governor states.

Chair Cheryl Powell asks for any public comment. None. Chair closes public comment.

Chair Cheryl Powell entertains a motion, moved by Betsy Young to put forth a motion to extend the HHDC light requirements to coincide with the Governor's requirements for outdoor dining and street scape, seconded by Cecelia Carey,

Betsy Young states that the wraps for the barriers were held up in shipment, delayed. Should be in by the end of the month, maybe earlier.

Chair Cheryl Powell presents some pictures, Exhibit E – artificial grass put down, in Norwood. Concrete barriers, with artistry painted on them and the artist signature. Maybe They may do like this in the future. There is a lot of narrowness where pedestrian walkways are on our Main Street now.

Jack Kay – Cape Cod Times article showed some selections that were made, Exhibit F, picture shown, waves on the barriers. Was a vertical striped pattern to.

Betsy Young confirms, waves will be on both sides.

Chair Chery Powell opens up public comment.

Tina Carey has put together a petition to remove barriers from Katy's Ice Cream to Tap City Grill on Main Street, Tap City has agreed as long as they can keep their barriers. Everyone is not in favor of this. The south side of Main Street businesses are hurting. No reason for these barriers. There are two handicap spots that no one can park in. This is all for the sake of about 5 restaurants, it's unfair to everybody else. Has no say in any of this. Other businesses that have long term have no say about what is going on on Main Street. Have to give up half our parking. Complaints on how it looks. People are avoiding Main Street because back up of traffic. She has handed in petition to Town Manager for removal.

Chair Cheryl Powell would like to table both sets of draft minutes to the next meeting. No objections.

Next HHDC meetings scheduled for June 16, 2021 and July 7, 2021

Elizabeth Jenkins stated that the Governor has ended the state of emergency and with it, that permission – all meetings, all public will have to be held in person after June 15th. Under OML as exists today, have to advertise as in person meetings. A new set of logistics may come with hybrid or remote, will continue to update.
