#### Update on Cranberry Bog Preservation

• Chair Canedy spoke with Janet Milkman of the Barnstable Land Trust and she is aware of the property. They are interested in the property if it becomes available. There may be a possibility of a conservation tax credit.

#### Update on Twin Brooks

- A group of ten residents have filed an appeal with MEPA with regard to the Barnstable Conservation Commission's determination on December 21, 2021. They are appealing the Commission's decision that the storm management pond was not subject to Conservation's jurisdiction under the Wetland Act.
- The Cape Cod Commission has determined the application from Lennar Multifamily Communities LLC is complete. A subcommittee will be formed to represent the Cape Cod Commission in negotiations with Lennar. A meeting will be scheduled for a public hearing sometime in February.
- Janet Milkman will be available to present alternative concepts for Twin Brooks in February.

# <u>Update on status of outstanding Conservation Restrictions-Harju, Amaral, Prince Ave, Wakeby, Commerce (Bowles), Silvia</u> No new information.

#### Update -Pathways Project- Doug Payson

A memo was received from David Anthony regarding the boardwalk behind the Trayser Museum. A grant is available and a scope of work has been created with costs. Coastal Engineering will flag the area around the wetland area for the new pathway. It will take ten weeks to complete the project. Once completed, the New England Mountain Biking Association will provide the labor and materials to build the bridge.

#### Report from Phyllis Miller/Tracy Pratt regarding Santuit Preserve

Member Pratt stated that there were many people using the walking trails after the snowfall. In the past, there would have been hardly anyone, but this seems to be changing. There was continued discussion about the pathways becoming very popular and a major source of recreation. Because they have a lot of use, it's important the trails are maintained and proper signage is in place. Some of the needs can be taken care of with volunteers and grant funds.

# Report from Farley Lewis regarding Community Preservation Committee Open Space applications.

Nothing new regarding open space applications. There is other activity occurring with CPC. Member Farley Lewis stated that Janet Milkman, Barnstable Land Trust, sent a letter to the Cape Cod Commission regarding redefining open space. For example, what is the definition of open space versus recreational space? The letter has sparked an interest in a public discussion of redevelopment and redefinition of open space. Towards that end, the Cape Cod Commission has scheduled Zoom Meetings to begin Wednesday, January 12<sup>th</sup> at 1:00 PM.

#### Report from Town Council Liaison Kris Clark

Councilor Clark met with Mark Ells to discuss the notice of intent that was needed for the bridge work behind Trayser Museum. Mr. Ells was also made aware of the time frame in which the work needed to be completed. This helped put in motion a plan and discussion with David Anthony, which resulted in the Committee having some updated information on the project tonight. The Town Manager agrees more attention needs to be paid to the pathways.
