1. Amend Innholder Wine & Malt License - Change of Manager

2. New Special One-Day Alcohol & Entertainment License

An application has been filed by Payomet Inc., to host **Ricki Lee Jones**, for a live music event with beer and wine service, to be held at Cape Cod Community College, Tilden Arts Center, 2240 Iyannough Road, West Barnstable, on October 20, 2024, from 5:00 p.m. to 7:00 p.m. Current TIPS certificate is on file.

PUBLIC HEARINGS

1. New Class II Auto Dealer License

An application was filed by Mega Motors, Inc. dba **Exit Auto**, 587 Iyannough Road, Hyannis for a new Class II Auto Dealer license. Maximum of 44 vehicles which includes 39 display, 2 customer, 2 employee,

and 2 handicap spaces. Repairs of inventory vehicles only will be conducted on-site. Daily hours of operation are Monday through Friday 9:00 a.m. to 6:00 p.m., Saturday 10:00 a.m. to 5:00 p.m. and Sunday 10:00 a.m. to 4:00 p.m.

2. Amend Common Victualler License

An application was filed by Whole Foods Market Group, Inc. dba **Whole Foods Market**, 790 Iyannough Road, Hyannis to amend the current common victualler license for a change of location from 990 Iyannough Road, Hyannis to 790 Iyannough Road, Hyannis. Inside seating for 65; outside seating for 14. Proposed hours of operation are daily from 8:00 a.m. to 9:00 p.m.

3. New Wine & Malt Common Victualler and New Daily Live & Daily Non-Live Entertainment Licenses

An application was filed by The Old Village Store LLC dba **The Old Village Store**, 2455 Meetinghouse Way, West Barnstable, for a new annual wine & malt common victualler license. Seating for 21, inside. Proposed alcohol manager is Cyrus Buffam. The proposed hours of alcohol service are Monday closed, Tuesday through Thursday & Sunday 11:00 a.m. to 7:00 p.m., Friday and Saturday 11:00 a.m. to 8:30 p.m. Daily Live entertainment is proposed for up to 4, non-amplified, performers and Daily Non-Live entertainment is proposed for background music below conversation level. Proposed hours of live and non-live entertainment will be commensurate with alcohol service hours.

In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours
