Lawler stated learning curve issues are transferrable. Both clients have been instructed to fully understand all lemon laws and associate rules and regulations. They are mature individuals. As far as splitting time. Marat and I will oversee Cash Point and we will hire a new manager. Edgar Gregorian does not have a lot of experience selling cars, Marat has more experience. Marat worked at a used car dealership for 2 years prior to opening Cash Point. Lt. Murphy has concerns but expects these individuals will be able to learn the business. Officer Gallant urged the applicants read the Rules and Regulations. Ms. Hartsgrove reiterated the purpose of the Rules and Regulations and reminded that if Cash Point were to have a change in manager, the manager must submit a CORI that meets the requirements.
