## LICENSING UPDATES

**Licensing Department updates:** Director Hartsgrove advised the Authority that question #3 did not pass during the recent elections so there will be no expansions to existing package store licenses.

Separately she advised that those business that wish to have an Outdoor Winter Dining agreement should apply now.

Renewal season and we need alcohol renewal forms before end of November. If the renewal form is not signed in the month of November license holders will need to apply as a new license.

Hartsgrove mentioned that staff will be holding the Annual Auto Dealer Compliance meeting on November 29<sup>th</sup> via Zoom at 1pm; for class I and class II auto dealers.

Decker asked when the town will remove the zoom meetings and go back to in person; Hartsgrove noted that Zoom will be allowed until April 1, 2023.
