Application made by Fire & Sirens, LLC dba *The Kettle Ho*, 12 School Street, Cotuit to transfer the Annual All Alcohol Common Victualler license and Daily Non-Live Entertainment from Clartin, Inc. dba The Kettle Ho to *Fire & Sirens, LLC dba The Kettle Ho*, 12 School Street, Cotuit. Hours of operation to remain Monday through Sunday 11AM to 12AM. The proposed manager is Peter Emerson. Noting the following premise description:

ONE STORY WOOD STRUCTURE APPROXIMAETLY 2,000 sq. ft. CONTAINING DINING AREA, CAFE AREA, COUNTER/BAR WITH SEATING FOR 18, KITCHEN, RESTROOMS, OFFICE AND BASEMENT FOR STORAGE. TWO ENTRANCES/EXITS ON SCHOOL STREET. SERVICE ENTRANCE TO KITCHEN IN REAR. MAXIMUM SEATING - 50 INCLUDING COUNTER/BAR STOOLS.

Applicant represented by Peter Emerson. Hoxie confirmed Peter is currently the manager and managing for the last few years. He started as a bar tender and has worked there since 2015. Emerson is purchasing the business with no changes to the operations at this time.

Applicant represented by Paul Delory. Pledge of the all alcohol license. M&T Made a commercial loan and a requirement of the collateral. Decker asked about the duration of the loan. December to December 2027.

#### 6. Amend Common Victualler, Daily Live and Daily Non-Live Entertainment

Application made by Great Awakening Coffee House Inc. dba *Great Awakening Coffee House,* 20 Independence Drive, Unit B, Hyannis, to

(1) Amend the hours of operation and Daily Non-Live hours from Monday through Saturday 7AM to 9PM and Sundays 1PM to 9PM to Monday through Sunday, 6AM to 10PM.

(2) Amend the Daily Live Entertainment license from 4 to 6 performers, and amend the hours of Live Entertainment from Fridays and Saturdays 5PM to 9PM *to* Monday through Sunday, 6AM to 10PM

Applicant Ina Taylor is present. Decker questioned the hours of operation. Nancy asked if there is enough area for 6 performeres. Decker questioned if 6 performers was allowed. Kelsey noted that historically the # of entertainers does vary. Approval can be dictated by the facility; noting that 6 is not unheard of and location should be taken into consideration. Mitrokostas asked if the neighboring businesses have complained. Ms. Taylor noted that they have become good friend with neighbors and have had no compliants. Hoxie is in favor of 6 performers.

# 7. Amend Common Victualler All Alcohol, Daily Live and Daily Non-Live Entertainment

Application made by Sunny Boy, Inc. dba *Kookoos*, 372 Main Street, Hyannis to make the following amendments:

- 1. Change the DBA on the All Alcohol Common Victualler, Daily Live Entertainment and Daily Non-Live Entertainment from Downtown Bistro to **Kookoos**
- 2. Change of Corporate Structure and ownership interest from Corporation to Partnership
- 3. Change the License Class from Annual to Seasonal
- 4. Alteration of Premise to remove one table and extend the bar seating. New premise description as follows:

372 Main St., Hyannis wood frame building with entrances on Main Street and North Street. Interior space approximately 2450 sq. feet. Total Seating is 145. Interior seating of 81, dining room - 62 and bar -19. Outdoor seating is 64, front – 28 and rear – 36.

Applicant represented by Tim Gaudette. They want to move to seasonal open for lunch and dinner. Decker asked if the corporation is being desolved; Gaudette advised it was just a DBA change. They will have a similar menu and increase capacity by 4 seats.

Application made by Hyannis LSOF Operation LLC. dba *Cape Codder Resort*, 1225 Iyannough Road, Hyannis to transfer the Annual All Alcohol Inn Holder, Daily Live, and Daily Non-Live Entertainment licenses from Hearth'n Kettle of Hyannis Inc. dba Cape Codder Resort to Hyannis LSOF Operation LLC. dba *Cape Codder Resort*, 1225 Iyannough Road, Hyannis. Proposed manager of record is Rachel Thayer. Daily Live Entertainment includes live amplified music with dancing; Daily Non Live Entertainment includes 42 video games. Premise description to read as follows:

Concrete block with brick and wood veneer building with one exit/entrance of Route 132 and one entrance/exit on Bearse's Way. 261 unit hotel containing 9 meeting rooms, lobby, one lounge, two restaurants, deck, outdoor pool, courtyard, indoor pool and waterpark with café,

spa, fitness center and arcade. Basement has 5 meeting rooms; seating capacity totaling 634 as well as assorted office space. First floor seating capacity totaling 1,046; two restaurants (seating 82 & 279), one lounge seating 94, lobby, 5 meeting rooms with seating capacity totaling 591. Also an outdoor pool seating 80, waterpark and café seating 258, courtyard, fitness center, guest rooms and arcade.

Applicant represented by Tyler Hensler, Attorney. Hensler advised the applicant is seeking alcohol and entertainment licenses. Also a pledge of the license. Cape Codder is the DBA. No immediate operation changes at this time. Lindcrust Hotel Group are the principals and will operate this with a management agreement. Rachel Thayer has been the General Manager of other major hotel groups. Pledge of the license will be Harbor One.
