Felicia Penn comments that she was on the Planning Board when the 2010 plan was formed. Significant language in that plan to grow broadband, renewable energy and medical support services, etc. Unless the town helps to create higher paying opportunities, we will not see the bigger picture. The point of economic development is to benefit the community.

Cheryl Powell asks for more information about a proposal for a housing service office. A regional service office would benefit both municipalities and developers to create affordable housing.

Meaghan Mort asks about affordable versus market rate housing in Barnstable, there is an overlap. Numbers come from the federal government and focus on attainable housing should be the goal.

Lindsey Counsell asks about the streets from one way to two way traffic.

Wendy Northcross inquiries about the Winter Community Service Officers (CSO's).

Review & Next Steps on Visioning Engagement:

 - Kate Maldonado shares that they are busy in the community with coffee hours, Halloween on Main Street, civic association meetings, rolling rally, love live local, village strolls. Have been busy handing out postcards and getting people to take the survey. The Winter Open House will take place at the HYCC on 12/14. Kate informs the members that we have material to pass along for events.

 - o Bringing it Together Meeting
 - Jill Slankas, Barrett Planning Group reports on the bringing it all together meetings that will be led by the firm of Dodson & Flinker. Goal is to develop a community vision to guide future growth and change in Barnstable. Tentative dates for this workshop are February 6, 7 & 9 2023 or February 13, 14 & 16 2023. Follow up email will be forwarded. Location target for this meeting will be the Barnstable Adult Community Center.

Asks committee to start to think about type of resources are needed to move this forward. Barrett Planning Group is only funded through phase one. Presentation tonight went through the chapters in the current plan and how do they fit in the new plan. Planning is a process connecting with the community as a town.

Felicia Penn has had community feedback about the local comprehensive plan process and concerns. She wanted to share with the group.

Amanda Converse is under the impression that some of the studies going on now are an extension of the 2010 plan and staff cannot be focusing all their efforts on this, has to be fluid.

Mark Hansen questions like form based code and great streets are more of an immediate need. Some areas that need improvement like the waterfront, no people in trades under the age of 65, we need to expand things we already have. We have some things that are way under-utilized.

Cheryl Powell seeks confirmation on having a housing plan to the Town Council in March.

Wendy Northcross, this group's role is to get the vision of economic development going. What opportunities can the future bring?

Lindsey Counsell feels we should look at the 2010 plan and see what has not been done yet so we can make decisions before going back to the town council for additional funding.

Councilor Kris Clark asks if the handouts the committee members are looking at are available online. Also makes a suggestion about going to the library for outreach.
