Chapter 91 License Application for Cape Wind Associates, for locations in Yarmouth and Barnstable from the Department of Environmental Protection, Waterways Regulation Program Commonwealth of Massachusetts, Executive Office of Energy and Environmental Affairs to construct and maintain two submarine electric transmission cables and fiber optic cables within the municipalities of Barnstable and Yarmouth in flowed tidelands of Lewis Bay and Nantucket Sound.
