Continued Public Hearing for Regulatory Agreement Application 2008-02 which is a Modification of Regulatory Agreement 2007-02 previously approved for the Greenery Development, LLC. The properties are addressed 42A and 42B South Street, and 89 Lewis Bay Road, Hyannis, MA located in the Hyannis Village Medical Services District and shown on Assessor's Map 327 as Parcels 241 and 223, respectively.

### 7:30 PUBLIC HEARING - Regulatory Agreement 2008-03 Impulse, LLC/Hilton Garden Inn

Regulatory Agreement Application 2008-03 has been filed requesting relief from Barnstable Town Ordinance Section 240-24.1.8 Hyannis Gateway District to authorize construction and use of a hotel with a total floor area greater than 10,000 s.f., which use is not permitted in the Hyannis Gateway District, and where the change of use may increase number of vehicle trips per day to a location on Route 28. The applicant seeks to raze two existing buildings and redevelop the 2.3 acre parcel with a 5-story, 133-room Hilton Garden Inn. Additional requested relief is for height in excess of 40 ft; landscape, parking, and front yard setbacks; parking calculations and lot configurations; lot coverage, and relief from Wellhead Protection Overlay District lot coverage requirements under a pre-existing nonconformity. Also, relief is sought as needed for site development standards, signage and buffers. The applicant is Impulse, LLC. The property is addressed 349 & 333 Iyannough Road (Rte. 28) Hyannis, MA and is shown on Assessor's Map 328 as Parcels 068 & 069 respectively in the Hyannis Gateway and Wellhead Protection Overlay Districts.
