Sandy Neck Board Meeting February 12, 2018

A regularly scheduled meeting of the Sandy Neck Board was held on February 12, 2018 in the Selectmen's Conference Room, 367 Main Street, Hyannis, MA. The meeting was called to order at 7:30 pm by Chairman Richard French.

Act on Minutes:

• On a **motion** by Bill Munroe and seconded by Tom O'Neill, the Sandy Neck Board voted to approve the January 08, 2018 minutes as printed.

Correspondence:

• A letter from Massachusetts Beach Buggy Association Inc. (MBBA) was read by Chairman Rich French. MBBA would like to have a beach clean-up day on Saturday April 21, 2018 at Sandy Neck. (Letter attached).

Staff Report:

Nina Coleman addressed the Board:

- Thanks to MBBA for taking on the task of beach clean-up again this year. The date and information will be put on the website.
- The Gatehouse repairs are coming along from the flood (Grayson storm). New insulation was blown in. New drywall is up. Paint and flooring to be completed next. Hoping to have it completed by the end of February. March plans include renewal applications, hiring and fencing. Very busy month.
- The ORV beach is open 8 am to 4 pm. The Gatehouse is not open. Staff is there but the Gatehouse cannot open yet no electricity.
 - Still snowy owls on the beach.

ORV Renewal Applications:

• The renewal applications will be done differently this year. They will not be mailed out. This will save thousands of dollars. There will be an email blast sent out to last year's permit holders with the information. The applications will also be available on the website. Permit application will have the following important information:

Dear Sandy Neck Off Road Vehicle (ORV) Beach Patron,

We are committed to providing a safe and enjoyable ORV beach experience.

A few reminders for the 2018 ORV beach season:

- 1) Due to the popularity of Sandy Neck, we anticipate that there will be times when we will have to close the ORV beach due to overcrowding. This will be a safety decision made by staff. If this happens you will not be allowed to "save a spot" for a friend.
- 2) We understand that being turned away will be disappointing, so we have developed an APP for your smart phone that will provide you real time updated information. The link to the SNK APP is on the front page of our website at www.townofbarnstable/sandyneck.park/
- 3) Alcohol is not permitted on Sandy Neck Beach Park.
- 4) Fireworks (including sky lanterns) are not permitted in the state of Massachusetts.

Thank you for your continued interest in Sandy Neck Beach Park.

Discussion:

Safety Solutions: (Review of what was previously discussed and agreed upon):

- > Limit number of vehicles,
- > Create Sandy Neck App,
- > Inform public about management changes,
- Work with PD to set the tone,
- > Increase PD presence on Sunday,
- Campaign = "if you see something say something",
- > Zone patrolling,
- > Updating Sandy Neck Regulations,
- > Updating guidelines for staff regarding alcohol use,
- > Safety improvements on Sandy Neck Road such as speed bumps and signage,
- > Cameras at gatehouse for safety of gatehouse personnel.

Trail Repairs:

- Meeting with DPW regarding trail repairs. It will be done this spring in March.
- Cottagers are planning to do their repairs from the storm in late March and April. Reminder: the dumpster is only for household trash! Nothing else. It is disrespectful and costs money and staff time when other items are put in the dumpsters.

Old Business:

Update - Long-term Coastal Resiliency Alternatives Report Pete Sampou addressed the Board.

- He has reached out to the four new Town Councilors Matthew Levesque, Britt Beedenbender, Paula Schnepp and Paul Neary. One phone call and two letters. Only Paula Schnepp has responded and he is meeting with her tomorrow (February 13th). He has not heard back from the other three councilors. He will follow up again. This will be the third time he has written to them.
- Rich French asked the Board if they felt a letter should be sent (again) to the entire town council seeking a letter of support.
- Pete Sampou stated he will write another letter to the every councilor.

A motion was made by Wendy Paquette and seconded by Tom O'Neill asking Pete Sampou to write a letter to Town Council for seeking their support of the Long-Term Coastal Resiliency Alternative Report. **Discussion:** Included in the letter will be information regarding the environmental issues, the potential revenue loss, safety concerns, and beach access. Also, there will be a reminder that Sandy Neck is an enterprise account. If the Council would like, there could be a presentation to the full council outlining all that has been done so far. **Vote:** All yes.

New Business:

Policy Changes

Nina Coleman addressed the Board.

The entire policy is attached at the end [Changes in red]. However, the only change is that dogs are allowed on Sandy Neck hiking trails anytime of the year as long as they remain on a leash from March 1st through October 31st (not Sept 15th). All dogs on the ORV corridor must be leashed unless in the waters of the Cape Cod Bay from March 1st to October 31st. In addition, areas that have high wildlife value will be marked as "No Dogs Allowed."

A motion was made by Tom O'Neill and seconded by Pete Sampou to support the Sandy Neck Beach Park Management Policies changes discussed tonight. The document revised date is February 12, 2018. Vote: All yes.

Matters not reasonably anticipated by the Chair:

Pete Sampou mentioned his two visits to the Halfway House. As a result of the Grayson storm, there was some water damage. He felt it could be cleaned and the cottage survived the storm. He will bring some students out to do the cleaning and will report back the progress.



Dear Nina,

We are currently scheduling our beach projects for 2018 and would like to extend our offer of assistance for work needed to prepare your beach for the upcoming season.

We have set aside the date of Saturday April 21nd. for the 2018 Sandy Neck Beach Conservation Project. We would like your permission to arrive on Friday afternoon and use a portion of the lower parking lot as an overnight holding area.

It is requested that the beach managers supply the trash bags for the projects, in the past we got the heavy yellow bags from the state, but they are difficult to get these days. Also please indicate where you would like us to leave the filled bags.

We do conservation projects on many of the beaches from the New Hampshire state line to the Rhode Island border. We plant beach grass, put up fence for erosion control, and pick up trash.

Sandy Neck Beach Park Management Policies
Adopted by the Sandy Neck Board on February 7, 2005
Revised; March 9, 2009, March 8, 2010, November 14, 2011, April 14, 2014 March 14, 2016 and February 12, 2018.

Complaints concerning policies, regulations, and/or Sandy Neck staff conduct should be addressed to the Park Manager or Senior Natural Resource Officer.

Section 1: Sandy Neck Fees

Sandy Neck user fees are at set rates depending on residency status. Residency must be proven per the Sandy Neck Beach Park Regulations and Sandy Neck Beach Park

Section 2: No Refund Policy

Section 3: Parking Lot Policies

Dogs are prohibited from all Barnstable bathing beaches (Town of Barnstable General Ordinances §403-8) from May 15 to September 15. Dogs are not allowed within a permitted vehicle that is traveling to the Off Road Vehicle beach. past the Gatehouse between May 15 and September 15 unless they are contained

Dogs are allowed on Sandy Neck hiking trails anytime of the year as long as they remain on a leash from March 1st through September 15th October 31st.

All dogs on the ORV corridor must be leashed unless in the waters of the Cape Cod Bay from March 1st through September 15th October 31st. In addition, areas that have high wildlife value will be marked as "No Dogs Allowed.

3:2 Drive-Thru(s) and Drop Offs

Section 4: Proof of Residency

Barnstable residents wishing to obtain an ORV Permit must have their vehicle registered in their name (or the name of a person residing year-round at the same address) unless:

- They have written permission to use a company vehicle.
- Proof of ownership of the company on the vehicle registration.
- A minimum one year vehicle lease agreement.

To clarify, the Barnstable resident/taxpayer <u>must be the applicant</u>. The vehicle must be (1) in the resident/taxpayer's name (2) in the name of a person living year-round at the same address or (3) in the name of the company that the resident/taxpayer owns or works for (with written proof).

Section 5: Off Road Vehicle (ORV) Permits

Barnstable General Ordinances Chapter 177, Article I, §177-2 requires that all over sand vehicles on Sandy Neck must have a current ORV permit. Only official vehicles (as determined by the Park Manager) are exempt from this requirement.

ORV permits are non-transferable. Permits may be re-issued to the same beach patron (or someone residing at the same address) providing the original permit is returned or there is documented proof that the permit was destroyed.

Section 6: User Conduct

All users of Sandy Neck Beach Park are expected to behave in a civil and responsible manner. Verbal abuse and/or aggressive behavior toward Sandy Neck Staff or other beach patrons will result in the violator's removal from the beach for not less than 24 hours. In addition, violators may have their ORV Permit revoked, incur fines for obscene language in accordance with Town of Barnstable General Ordinances §147-1 and/or be issued trespass orders.

Section 7: Property Owner Off Road Vehicle (ORV) Permits

7:1 Eligibility

Property Owner ORV Permits will be issued to Sandy Neck property owners, Sandy Neck property lessees (minimum one year lease) and immediate members of their family. Immediate family members include father, mother, sister, brother, husband/wife or partner, son and daughter (including step-son and/or step-daughter).

7:2 Proof of Eligibility

It is the responsibility of the applicant to prove ownership or lessee status. Immediate family relationships can be proven by a legal document such as a birth certificate, marriage certificate or notarized letter.

7:3 Property Owner ORV permit privileges

The Property Owner ORV Permit affords access (via open Sandy Neck trails) to the applicable cottage only. It also allows vehicle use of the front beach (open sections only) for recreational purposes and use of the air compressor. In addition, the cottage owner may use the Sandy Neck dumpster to discard ORV and household trash. Dumping of construction debris, hazardous waste, discarded equipment, or any other items that are not ORV or household trash is strictly forbidden and will result in fines.

7:4 Guests of Property Owners

Guests of property owners may park in the Sandy Neck Parking lot. However, in-season guests are responsible for appropriate daily fee or parking permit for the entirety of their stay. Guests may park in the parking lot out-of-season at no cost.

If the guest intends on driving to a cottage, he/she must purchase the appropriate Sandy Neck Non-resident or Barnstable ORV Permit. Sandy Neck staff will issue a trail pass only after the Cottage Owner has alerted the Gatehouse that a particular individual can access their cottage.

Section 8: Halfway House Usage

8:1 Intent

The purpose of this recommendation is to provide clear direction and consistency for the Park Manager and the potential users and/or advocates interested in maintaining the special nature and use of the Halfway House.

8:2 Eligibility

The Halfway House has a long and stable history of educational and research based occupancy (spanning more than 30 yrs). It was regularly used by the Barmstable High School as part of a coastal ecology program. For the last twenty years the Halfway House has been used as a college level research station.

However, there are groups of people besides scientists that can impart a lasting benefit to the ecology and unique nature of Sandy Neck and the community of greater Barnstable. These groups must receive no monetary benefit from access to the Halfway House rather they might request to access this shelter because of the uniquely serene and beautiful environs the Halfway House offers. For a set fee (or another form of donation acceptable by the Sandy Neck Park Manager) certified non-profit groups that run art or nature based educational programs should have the ability to visit and/or stay at the Halfway House.

In addition, the Halfway House should continue to be used by science based educators and researchers in exchange for services and/or monies that these groups have traditionally provided to Sandy Neck.

While the Halfway House can always provide emergency shelter for youth groups, it is not the intention of these policies to suggest that young people (who can make use of the existing camping facilities at Trail 4) should have access to the Halfway House unless there is a reason that camping is not feasible. Requests from such groups will be considered on their respective merit and judged by the Sandy Neck Park Manager on a case by case basis.

8:2 Permit Requirements

Interested non-profit educational, scientific and art groups may apply for consideration for use of the Halfway House. If selected, the organization would be granted a Special Permit that will set fees and usage guidelines. In addition, insurance and liability waver requirements will be set forth under a Sandy Neck Beach Park License Agreement.
