**ORDERED:** That pursuant to the provisions of the Community Preservation Act, G.L. c 44B, the sum of Thirty Three Thousand One Hundred Twenty Six and No/100 (\$33,126.00) Dollars be appropriated and transferred from the amount set aside for historic preservation in the Community Preservation Fund to be expended to fund the preservation and restoration of historic documents consisting of twenty-two of the oldest Town record books containing births, deaths, and marriages for years 1643 to 1966. Preservation methods include: scanning to compact disc, de-acidification, mending and reinforcing of paper, re-sewing, rebinding or archival grade polyester encapsulation as needed; and that the Town Manager is authorized to expend the amounts appropriated for the stated purposes.

**BACKGROUND:** The Community Preservation Committee voted on December 21, 2015 to support a funding request from the Town Clerk in the amount of \$33,126.00 for preservation and restoration of the oldest Town vital record books and to recommend through the Town Manager that the Town Council approve an appropriation from the Community Preservation Committee historic preservation funds. A professional survey of Town records indicates that twenty-two of the oldest books beginning with the years 1643 to 1966, including a handwritten copy of the Declaration of Independence within, are the records most in need of preservation. Page edges are disintegrating simply due to exposure to air and therefore content is being lost. Handling of the books in response to public record requests must be performed by staff wearing white gloves due to their condition. Methods of preservation include: scanning to compact disc, de-acidification, mending and reinforcing of paper, re-sewing, rebinding or archival grade polyester encapsulation as needed. The scanning of records to compact disc will allow the preserved original record books to be stored in a climate controlled, fireproof vault in the Town Clerk's office, while allowing Town staff and the public, access to these historic records in an efficient, searchable format through laser fiche.

**FISCAL IMPACT:** There is no impact to the general fund. All funds are drawn from the Community Preservation Committee, historic preservation funds.

**BACKGROUND:** Barnstable Police Department applied for and was awarded the Federal Fiscal Year 2015 Emergency Management Grant from the Massachusetts Emergency Management Agency (MEMA) in the amount of \$14,460. The Barnstable Police Department coordinates the emergency management operations for the Town of Barnstable and the Chief of Police serves as the Emergency Management Director. Many of the portable radios used by Emergency Management personnel within the department are in excess of 25 years old and are obsolete in terms of parts availability and in meeting optimum levels of interoperable communications standards. In the event of an emergency, it is imperative that emergency management personnel have the ability to communicate regionally with all Cape Cod police and fire departments, the Barnstable County Sheriff's Department and the Massachusetts State Police. The grant will be utilized for the upgrade of 4 portable radios and high capacity radio batteries.

**ANALYSIS:** The acceptance of this grant will allow the Department to update and purchase equipment that will be a vital tool in emergency operations. All equipment must be purchased by 6/30/16.

**FISCAL IMPACT:** This grant requires a 100% match, which is met via a formula provided in the grant in which it is determined that 15% of the police chief's salary over the 12-month period of the grant is spent on emergency management-related work and equals no less than the equivalent of the grant amount of \$14,460.

**TOWN MANAGER RECOMMENDATION:** Thomas K. Lynch, Town Manager recommends acceptance of this grant.

**BACKGROUND:** The use of heroin frequently results in a drug overdose and death. The Barnstable Police Department applied for, and was awarded a First Responder Naloxone (Narcan) Grant from the Massachusetts Executive Office of Health and Human Services Department, Public Health – Bureau of Substance Abuse Services in the amount of \$16,000. \$15,000 of the grant will fund the purchase of Narcan, which is administered by officers in incidents involving an opiate-related drug overdose. Narcan is an opiate overdose antidote. This grant will also provide \$1,000 of funding for informational posters/brochures to be utilized at the 2016 Youth Summit, which is an important drug education event of the Barnstable Youth Commission.

**ANALYSIS:** The acceptance of this grant will allow the Barnstable Police Department to purchase Narcan, as well as assist the Barnstable Youth Commission by funding informational drug education posters/brochures for use at the 2016 Youth Summit.

FISCAL IMPACT: There is no match on this grant.

The mission of this grant is to develop or enhance effective pedestrian and bicycle enforcement to reduce fatalities and injuries in these areas. The work of the grant will include targeted enforcements on Main Street in Hyannis and streets around Cape Cod Mall, for the purpose of increasing compliance with traffic laws by pedestrians, bicycles, and motorists. The grant also includes an educational component directed towards safe and proper street crossing in the areas of the Sturgis Charter School and Barnstable High School. Overall, the greatest benefit of this grant will be in raising awareness of these safety concerns with motorists and with pedestrians, which hopefully will have a lasting effect in reducing unsafe behaviors.

**BACKGROUND:** Due to Cape Cod, and more specifically the Village of Hyannis, being a popular summer vacation destination for both older teens, young adults and young/college-age seasonal workers coupled with a large number of licensed liquor establishments within a small geographic radius there is historically an increased chance that these young individuals under the age of 21 will be attempting to obtain alcohol at either a bar or other establishment and/or at a liquor store. Unfortunately, the drinking of alcoholic beverages is a popular activity for this age group, especially as they frequently have the mentality that they are "on vacation" or that they are "away from home" and therefore exhibit behavior they might not otherwise be as easily able to exhibit if they were at home with a parent or other adults supervising them. This grant will enable the department to conduct sting operations, compliance checks, party patrols and monitor liquor store activity.

**ANALYSIS:** Acceptance of this grant will assist the Department in providing this safety program, which is especially important in preventing motor vehicle injuries and fatalities involving person under 21.

**GRANT DETAIL:** The \$9,960 grant will be directed towards overtime for enforcement hours for compliance checks, sting operations, cops in shops and surveillance patrols.

**FISCAL IMPACT**: This grant will supplement the currently allocated funds. There is a required match that will be satisfied using currently allocated department resources and in-kind matches.

**BACKGROUND:** The Council on Aging (COA) is a multiple member appointed advisory board under the authority of the Town Council. BACKGROUND: The Community Preservation Committee voted on January 25, 2016 to support a funding request from Tales of Cape Cod in the amount of \$85,000 for historic preservation and restoration of the Olde Colonial Courthouse located at 3046 Main Street, Barnstable representing 50% of the total cost of Phase 1 work. This request for historic CPA funds is reliant on the awarding of a Massachusetts Cultural Council grant representing the other 50% of the total and the required match for the State grant. A Historic Structure Report was completed in January 2015 and based upon the findings and recommendations a multi-phased program to restore and preserve the Olde Colonial Courthouse has been developed. The Old Colonial Courthouse is a "contributing property" in both the Barnstable Village Historic District and the Olde King's Highway Historic District. The building was constructed between 1763 and 1774 as a Colonial Courthouse. Following the Revolutionary War, it became the Courthouse for the Superior Court of Barnstable County. In 1842 the building was sold to the Third Baptist Church of Barnstable and was renovated into a house of worship retaining the same footprint, foundation, and most of the original framing materials, until 1972 when Tales of Cape Cod acquired it. The past events that have occurred in this building are of historical significance, and the current use of the building for lectures, meetings, and private events contributes to the character of the community. Phase 1 work includes roof repair, gutters and leaders, siding and trim, foundation repair, electrical system upgrade, basement entry gable, repair/replacement of porches and stairs and the removal of an exterior brick chimney that is no longer used.

**FISCAL IMPACT:** There is no impact to the general fund. All funds are drawn from the Community Preservation Fund.

**BACKGROUND:** Growth Management Department, working with the Building Commissioner and Department of Public Works (DPW) Structures & Grounds Foreman Brian Lauzon, has identified necessary repairs to the shanty boardwalk and the shanties themselves. Over the ten years of its use, the boardwalk has sustained wear and tear and now presents some tripping hazards and weakened areas along its length. The Building Commissioner is confident that the repairs specified by DPW Structures& Grounds will fully address the maintenance issues which include tripping hazards. The shanty buildings need some bracing on the underside of the floors as recommended by the Building Commissioner.

The Shanty artist incubator program has continued to grow over its ten year span. The more than 500 Shanty artists have attracted over 850,000 visitors and reported more than \$1,700,000 in receipts in that time. Several artists have gone on to open their own retail outlets

This budget is based on estimates from DPW Structures and includes specified materials, landscape repair after construction, and labor costs. Our goal is to complete these repairs before the May 13th opening of the 2016 Shanty season.

**FISCAL IMPACT:** The Bismore Park Special Revenue Fund has sufficient resources to fund these repairs which follow the fund purpose. The current balance in the account is \$ 388,000. Gross revenue generated from Bismore parking meter receipts in fiscal year 2015 was \$300,000.

**TOWN MANAGER RECOMMENDATION:** Thomas K. Lynch, Town Manager recommends approval of this fund transfer.
