SUBJECT: Waiver of fees for construction work on the new Hyannis Fire District Fire Station

located at 95 High School Road, Hyannis, MA

BACKGROUND: Since getting voter approval to proceed with construction of a new Hyannis Fire District firehouse in April architects have been preparing plans and documents to go out to bid. Along with the bid documents being prepared are plans and documents to submit to the Town of Barnstable Building Division for building permits.

According to documents provided to the Hyannis Fire District by Mr. Jeff Rudziak, Director of the Town of Barnstable Assessing Division, the Town of Barnstable owns 199 tax exempt properties in the Hyannis Fire District valued at \$336,867,000. This does not include the 63 tax exempt properties in Hyannis owned by the Barnstable Housing Authority.

The taxpayers of the Hyannis Fire District provide fire and rescue services to these 262 properties without benefit of any tax money from the Town of Barnstable. These properties are used by and benefit all the residents of the Town of Barnstable. Because of the services provided to the town we respectfully request that the Town of Barnstable Building Division waive any and all permit fees associated with this project.

Richard Scali, Town of Barnstable Director of Regulatory Services, has indicated that he has no objections to waiving the fees and sees no additional inspectional costs to the town.

SUBJECT: Order to Approve Term of Contract Change under the MGL 30B, Uniform Procurement

Act, Section 12, paragraph(b), which would allow the Hyannis Golf Course Golf Car

contract to be extended from three (3) years to five (5) years

RATIONALE: The Town of Barnstable's current golf car contract for Hyannis Golf Course is with Five Star Golf Car & Utility Vehicles, LLC will end on March 31, 2017. A request for quotation was issued by the procurement office under the State Contract FAC88 for golf cars and utility vehicles for the Hyannis Golf Course (HGC) (76 cars plus six (6) utility vehicles and three (3) support cars) on August 15, 2016 from three state contract vendors as required by the state contract. Request for Quotes (RFQ) were sent to:

- 1. Country Club Enterprise
- 2. Five Star Golf Cars
- 3. New England Golf Cars

The state contract allows the municipalities to award their procurement to the "best value" to them. The request for quote stated that the award would be made based on all factors of the equipment, options, pricing and product and vendor performance/references and will be considered in determining the best value for the Barnstable Golf Division.

Quotes received from two firms as follows:

36 month lease/60 month lease

- 1. Country Club(Club Car) \$248,583.04/\$323,437.00
- 2. New England Golf (Yamaha) \$223,625.46/\$297,556.80

Five Star (No response)

Due to the large quantity of golf cars and to seek a greater quantity price discount, as suggested by the state contract office, during the equipment evaluation process, both firms were requested to review their pricing and submit their best and final pricing offer to the procurement office by 9/8/16.

Revised pricing received as follows:

LEASE PRICING

36 month lease/60 month lease

- 1. Country Club\$218,031.84/\$300,287.40
- 2. New England Golf \$219,500.00/ \$293,254.20

The evaluation of the golf cars and utility vehicles offered by County Club Enterprises (CCE) and New England Golf Cars (NEGC) was done by the following: Bruce McIntyre, Director of Golf Operations; Christopher White, Director of Golf Maintenance; Golf Maintenance Staff; Jesse Schechtman, Hyannis Golf Professional; and Golf Operational Staff. This recommendation is based on feedback from customers using demo golf cars, staff using demo utility vehicles, vehicle course performance, cart comfort, service plan offerings, reference checks, comparisons with current golf cars, history with the two vendors that submitted bids, current price paid and bid prices proposed.

The Town Council previously approved the current cart contract from a three (3) to five (5) year term.

FISCAL IMPACT: New competitive state contract quote process resulted in a reduction of yearly lease cost at HGC over the current lease from Five Star of \$7,587.16 for a total of \$37,935.80 cost savings over the five (5) year lease. There is an estimated 30% increase in fuel efficiency with fuel injected motors which will result in higher profits on a lower expense with this new fleet.

SUBJECT: Change of Polling Location for Precinct 11 to the Barnstable West Barnstable Elementary

School located at 2463 Main Street, West Barnstable, MA 02668

RATIONALE: On March 1, 2016, the United States Attorney's Office (USAO) for the District of Massachusetts conducted a compliance review under Title II of the American with Disabilities Act (ADA) of the Town of Barnstable voting program. In the course of its review, the USAO visited several polling places including the West Barnstable Community Center. By letter dated September 15, 2016, the USAO outlined the steps that the Town must take to meet the 2010 ADA Standards for Accessible Design. Two members of the Town's Disability Commission, the Director of the Department of Public Works, the Town Architect, the Supervisor of Structures and Grounds and the Town Clerk visited the several of the polling locations in question, including the West Barnstable Community Building. It was determined that corrections could be made at the other identified locations in advance of the November 8th election. However, to address the 2010 ADA Standards for Accessible Design (which are more stringent than the State requirements) at the West Barnstable Community Building would be very costly, even if they could be accomplished prior to the November 8th election. Relocating the polling location to the Barnstable West Barnstable Elementary School, which will be closed on Election Day, is the most logical and cost effective solution. Under state law, notification to households with one or more registered voters will be mailed. A printed description of the changed polling location will be posted at several locations within Precinct 11. With the availability of early voting and absentee ballots, there will be other avenues for all voters to cast ballots in advance of the November 8th election.

TOWN MANAGER RECOMMENDATION: Mark S. Ells, Town Manager recommends approval of this change of polling location for Precinct 11 to the Barnstable West Barnstable Elementary School.
