## 2024-020 DETERMINATION UNDER SECTION 19 OF THE CONFLICT OF INTEREST LAW REGARDING PARTICIPATION IN MATTERS RELATING TO POTENTIAL CHANGES TO THE PERCENTAGE CONTRIBUTIONS OF THE TOWN AND ITS EMPLOYEES FOR HEALTH INSURANCE

**RESOLVED:** That the Town Council does hereby determine that the financial interest of Mark Ells in matters regarding and relating to a workshop discussion on potential changes to the health insurance percentage contributions of the Town and of its employees, as described in Mr. Ells' disclosure form presented to the Town Council at this meeting in accordance with G.L. c. 268A, § 19, is not so substantial as to be deemed likely to affect the integrity of the services which the Town may expect from Mr. Ells, thereby authorizing Mr. Ells to gather and analyze information to prepare for a workshop discussion, to participate in such discussion on this issue, including making recommendations to the Town Council, at either the August 17, 2023 or September 7, 2023 Town Council meeting, and to make determinations pursuant to G.L. c. 268A, § 19 for such other staff as he deems necessary and appropriate to assist him in such preparation and discussion; provided that any further participation in this matter after the workshop shall require further authorization from the Town Council; and further authorizes and directs the President of the Town Council to make such determination on Mr. Ells' disclosure form on behalf of the Town Council.

#### **SUMMARY**

SUBJECT:	Determination under Section 19 of the Conflict of Interest Law regarding participation in matters relating to potential changes to the percentage contributions of the town and its
	employees for health insurance

Section 19 of G.L. c. 268A, the state conflict of interest law, prohibits a municipal employee from participating in a particular matter in which he or she has a financial interest, unless the employee's appointing authority makes a determination that the financial interest is not so substantial as to be deemed likely to affect the integrity of the services which the Town may expect from the employee. Section 19 requires that an employee who wishes to participate in such a matter file a disclosure with the employee's appointing authority of the nature and circumstances of the particular matter and make full disclosure of the employee's financial interest prior to participating. If the appointing authority makes such a determination, then the employee may participate in the matter, notwithstanding his or her financial interest.

The percentage amount of health insurance contributions made by the Town and by its employees, respectively, is currently set by statute at a 50/50 split (G.L. c. 32B, sec. 7). If the Town accepts certain provisions of G.L. c. 32B, the Town may pay more, but not less, than 50% of the total monthly cost of such insurance. As set forth in Mr. Ells' Section 19 disclosure, Council leadership has requested a workshop discussion on this issue prior to the Town Council taking any votes to implement such a change and prior to authorizing Mr. Ells to participate in such matters. However, in order for Mr. Ells to prepare for and participate in such a workshop discussion, he would need authorization from the Town Council because he has a financial interest in such matters. Therefore, the authorization he is seeking is a limited one that would allow him to prepare for the workshop and participate in the workshop discussion, including making recommendations to the Council. It would also allow him to make determinations pursuant to G.L. c. 268A, sec. 19 for other staff that he deems necessary to assist him in this effort. However, any participation in this matter after the workshop would require further authorization from the Town Council

It should be noted that many of the members of the Town Council obtain their health insurance through the Town. Accordingly, those Councilors would have a financial interest in any decisions to decrease the employee health insurance contribution, including any decision to authorize Mr. Ells to participate in such matters. (Town Councilors are considered "municipal employees" for purposes of the conflict of interest law.) Because Councilors are elected and do not have an appointing authority who can give them permission to participate in this matter, Mr. Ells proposes that any potential changes that would be discussed at the workshop and any subsequent votes taken by the Town Council to authorize such changes would not be effective before December 1, 2023, after the next Town election in November 2023. Since all Councilor seats are up for election in November, a decision today by Councilors to authorize Mr. Ells to prepare for and participate in a workshop discussion regarding changes which would not be effective until after the upcoming election is not a matter in which the Council members have a reasonably foreseeable financial interest, as there is no way to know who will and will not be re-elected.

**FINANCIAL IMPACT:** There is no immediate and direct fiscal impact on the Town's operating budget as a result of this action.
