

Town Council Meeting June 3, 2021



The June 3, 2021 meeting of the Barnstable Town Council was physically closed to the public to avoid group congregation.

A quorum being duly present, President Matthew Levesque called the June 3, 2021, Town Council meeting to order at 7:02 PM from a remote location.

An announcement was made by President Levesque regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by Councilor Atsalis followed by a moment of silence.

#### PUBLIC COMMENT:

Whitney McNamara spoke in favor of the Accessory Dwelling Units (ADU's) please pass this as it stands. She encourages the Council to consider finding a way to have hybrid meetings.

Tina Carey talked about the barriers on Main Street, we do not hear back from the Town. We have handicapped spaces that are blocked, this is beyond incompetence. If you watch people walking down Main Street, they hop off the sidewalk and then back onto the sidewalk. You are hurting everyone's business; people are avoiding Main Street due to the barriers.

Meaghan Mort commented support of the ADU's, hoping the Town Council will move on that quickly.

Ronnie Aboudi talked about the barriers blocking his driveway and creating a loading zone right in front of his property. He talked to the Town Engineer, but the yellow stripes that were painted on the street are being ignored by everyone. He said he is sending emails and is being ignored, you are supposed to be taking care of us. Move those barricades away from my property, start listening to us.

#### **Response to Public Comment:**

(Atsalis) are we actually blocking handicapped spaces? (Ells) to my knowledge, there are five spaces involved, we are not in violation, we have added ramps to keep us handicapped compliant. We will look at these five spaces again to see if we can make changes. Ells has received emails from about 6 businesses regarding the barriers. We

needed to replicate the barriers; we made a commitment to the businesses that these will remain in place until August 15<sup>th</sup>. Situations change, we are paying attention to the west end, and to the businesses that have asked to remove the barriers. The suggestion that we are not listening, that we are not having conversations is incorrect. We will continue to look and modify where it is safe to do so. In discussions with our visitors, they are thrilled with the barriers on Main Street. The folks that have complained to me are using Main Street are a cut through to go west. We need to gather more information. (Clark) One of our Barnstable shell fishermen passed away, John Nawoichik, a committed shell fisherman that contributed to the fabric of our community. (Schnepp) Thanked the folks that showed up for public comment, this whole last year we want to keep the level of public engagement and are working with the town staff to make that possible.

## **Councilor questions and comments:**

(Levesque) We have scheduled a special meeting on August 5<sup>th</sup> to focus on the second fiscal policy discussion. (Bogan) Regarding the ARPA funds is there a time table for the working group to complete and when the funds would be distributed (Ells) no, there is no time table as yet, 5.3 billion dollars to be distributed, we can expend the funds through 2026. The State will probably utilize the revolving fund for wastewater, and broadband. The focus will probably be on the larger longer term benefits, what the Commonwealth's goals are and what each community sees as their goals; (housing, infrastructure, and workforce training) as a use of the funds. Not for operating type programs; (Schnepp) does the meeting/working group have anything to do with 7 million dollars for the town (Ells) how does the town intend to use it, looking for our input, we have our first half now. The ARPA funding is based on the revenues we did not receive due to the pandemic; then spent on infrastructure programs, must show a link to COVID. (Schnepp) There is money through the County as well (Ells) Yes, the same criteria. (Schnepp) Short Term Rental (STR) will we have a report at our next meeting from the tracking through the database and the 1-800 number. (Ells) expect you will have the information before the next Town Council meeting (Clark) Regarding the trash train, any progress, do you have any information (Ells) nothing formal, effort to clean up from a variety of people, but have not received anything formal, nor has the Town Administrator in Yarmouth.

(Neary) Could you elaborate on the new revenues for this year? (Santos) basically for all the items we charge for separately, the additional sticker sales, we also have daily fees and per bag fees for those that do not buy a sticker (Neary) good to see that things may be turning around (Starr) we are still not charging enough, we are still using the reserves, the cost of the sticker doesn't cover the cost (Santos) that is correct, we have made a budget, the deficit we have subsidized with our reserve funds, by charging for the specialty items and gate fees have put us in the black, but it still does not cover the cost of operating.

(Neary) Do you anticipate to be down 20 to 30% this year (Servis) Put us lower as we expect to bounce back slowly (Clark) Hope the airport improves over the next year, concerned about contaminated area (Servis) The soil that was contaminated, both sights have been mitigated, capped to stop the continued rainwater getting into the ground. Showing improvements in that area and will continue to work with the DEP. (Dagwan) New facility fees could you speak to those and to the workman's compensation is that due to COVID (Servis) No workman's compensation due to COVID, we have a new 3 year agreement with car rental at the airport; airport is doing the advertisement rather than a third party (Cullum) brightest days of the Airport are coming, thankful for your leadership at the airport.

Open public hearing, seeing no one close public hearing Meg Mayo-Brown Barnstable Public Schools Superintendent, and Gareth Markwell, gave the rationale

## **Councilor questions and comments**

(Bogan) Supports educational funding, continue to hear the education budget always goes up, we see the decrease in enrollment, but the budget goes up, we have to tighten our belt a little bit, can you help me to explain this budget. (Mayo-Brown) we based the budget on the hope that the students will return, so we did not reduce our teaching staff (Markwell) new round of collective bargaining, some of the big costs are the areas of longevity, to have the best staff at all times for our students, moving away from lower paid staff, special education services, specialized autism program. (Mayo-Brown) the additional costs for transportation and separating children in the classrooms is part of that number; (Hebert) Compared to other school systems on Cape Cod, what is our rating and how does that compare (Mayo-Brown) Profile page that State has, we are making progress

to our goals. (Hebert) Are we about average compared to the other schools? (Mayo-Brown) we will have that information in August (Hebert) we are expected to do more with less for our students (Mayo-Brown) Agree with that statement; we have more English learning students. (Hebert) impressed with the degree of experience we are providing our students. (Mayo-Brown) We have a Chapter 74 program, a pathway from the high school to Cape Cod Community College. (Hebert) Most of the students going to Cape Cod Tech are from Barnstable, kudos for providing for those who are waiting for an opening at Cape Cod Tech. (Cullum) Appreciative of the dual enrollment program, helps to build a stronger community, parents look for a place to put their children, have concerns about the curriculum, talked about ESL (English Language Learners) there is no reason why a child can't learn a second language. The reason parents are sending their kids to private schools is to have communication, guidance is missing in the public schools. We need a customer service model to loop in the parents, which will help keep the students in the seats. We are talking about 63 cents on the dollar to the schools, this is an opportunity to teach two languages starting in elementary schools, I cannot support this budget. (Mayo-Brown) I agree with you on many fronts, our school district is culturally diverse, Barnstable Intermediate Schools has its trouble, and change takes 3 to 5 years that school is in the midst of redesigning. The work is on-going, we are making some progress. We are not sitting on our hands (Cullum) Simple communication pieces, if a child is getting a bad grade in an elective, why isn't that teacher reaching out; whenever I call everyone responds to me, these are basic things to keep the parents involved. (Mayo-Brown) I think we are very proactive, we are not there yet (Atsalis) Is it safe to assume that the cost of doing business was less do to COVID (Mayo-Brown) The cost of doing business was more, just to keep the kids 6 feet apart (Atsalis) Limited travel for sports teams, did the athletic department save money, what happened to that money (Markwell) Fees for athletics that parents pay roll over to the next year, unexpended general fund amounts go back to general fund (Atsalis) in the high school you have addressing equity gaps; what are the equity gaps and how are you addressing them (Mayo-Brown) One equity gap, we have four levels of classes, noticed most of our college prep classes are filled with students of color, worked with our counselors to move more students to higher level of learning. (Atsalis) Isn't that their choice (Mayo-Brown) I think that is on us to figure that out (Atsalis) does it change their learning experience of the students currently (Mayo-Brown) why should it? (Levesque) more of these questions will be good for our workshop, we need to stay on point. (Neary) Have a couple of questions, listing the expenditures per field or classroom and the rise in costs over time. Are these fixed costs or are they payroll costs (Markwell) these are an accumulation of all of the above, includes teachers, curriculum purchases, classroom supplies. (Neary) In certain areas, that maybe your quest for a qualified instructor that may be a higher cost (Markwell) purely an enrolment change in the number of English Language Learners that require additional support (Mayo-Brown) sometimes they need additional services, we have to look at each student individually. (Neary) Does the school department have any reserves or does it all go back to the general fund. (Markwell) Any unexpended appropriations for the purpose of education go into the

school savings account, to pay for additional educational costs. (Neary) what is the balance in the savings account (Markwell) I don't have that off the top of my head it is approximately 3.25 to 3.7 million. (Shaughnessy) Barnstable has a higher average salary; due to their years of service will we have mass retirements in the next 10 to 20 years? (Mayo-Brown) We have teachers in step 11 and 12; we have a number of veteran teachers that have maxed out. (Shaughnessy) maybe we will have teachers at 4 or 5, do we expect enrollment boost from COVID? (Levesque) Do we have to pay more for a certain type of counselors? (Mayo-Brown) we are providing more counseling, and mental health services.

(Atsalis) Was the decision to change calibers due to cost or something else (Chief) smaller calibers everyone can use and the cost is less. (Levesque) the general atmosphere is tough right now, I think the BPD does a great job, thank you for the job you do, and your guidance, I will be supporting this item.

- (1) Administrative Services, encompassing Legal, Information Technology, Human Resources and Finance;
- (2) Community Services, encompassing Recreation, Golf and Senior Services;
- (3) Inspectional Services, encompassing Building, Health and Weights and Measures;
- (4) Marine and Environmental Services, encompassing Harbormaster and Natural Resources;
- (5) Planning and Development, encompassing Regulatory Review, Comprehensive Planning, Community Development, Economic Development, Conservation and Parking;
- (6) Police; and
- (7) Public Works, encompassing Administration and Technical Support, Highway, Solid Waste, Structures and Grounds, Water Pollution Control and Water Supply."

## **SECTION 3**

That the Town Council hereby amends the Administrative Code, Chapter 241, Article IV, Municipal Organization, § 241-47.1, Town Manager, subsection D, Department heads, by striking subsection (1)(I) in its entirety.

## **SECTION 4**

That the Town Council hereby amends the Administrative Code, Chapter 241, Article IV, Municipal Organization, by deleting § 241-47.29, Licensing Department, in its entirety.

# **SECTION 5**

That the Town Council hereby amends the Administrative Code, Chapter 241, Article IV, Municipal Organization, § 241-47.1, Town Manager, by adding the following new subsection E:

"E. Licensing program. There shall be placed within the office of the Town Manager a Licensing program, which seeks to protect the public interest through enforcement of laws and regulations relating to licensing of certain businesses. The Licensing program operates pursuant to applicable provisions of the Town Code and the following state laws: MGL Chapter 100 concerning auctions; and MGL Chapters 136, 138 and 140 concerning licensing. The Licensing program provides administrative support, conducts inspections and compliance activities, and enforces laws and regulations regulating business entities licensed by the Town Manager and the Licensing Authority. The Licensing program provides enforcement of all licensing and issues related to special events on Town-owned property and public ways, private parking lots, underground storage tanks, narrative bus tours, outdoor dining and Pedi cabs. The Licensing program interacts with the Police, Planning and Development and Inspectional Services departments concerning licensing activities. The Licensing program interacts with various boards and committees with concurrent jurisdiction, such as Site Plan Review, Board of Health and Zoning Board of Appeals, and provides administrative and compliance support for the Licensing Authority."

# **SECTION 6**

That the Town Council hereby amends the Administrative Code, Chapter 241, Article IV, Municipal Organization, § 241-47.21, Inspectional Services Department, by adding the following new subsection C:

"C. Weights and Measures Division.

- 1. Purpose. The Weights and Measures Division seeks to protect the public interest through enforcement of laws and regulations relating to weights and measures of certain businesses.
- 2. Authorities and Responsibilities.

The Weights and Measures Division operates pursuant to applicable provisions of the Town Code and the following state laws: MGL Chapters 94 through 99 concerning weights and measures. The Weights and Measures Division is responsible for code compliance and enforcement of all laws pertaining to the sale of commodities by weight or measure, the inspection and testing of weighing and measuring devices, the operation and use of electronic retail checkout systems, the method of sale of commodities and the labeling of prepackaged commodities.

- 3. Interrelationships.
  - (1) Town Manager. The Weights and Measures Division interacts with the office of the Town Manager, including the Licensing program within that office, concerning administrative support, code compliance and enforcement of all issues relating to weights and measures.
  - (2) Other departments. The Weights and Measures Division interacts with the Police and Planning and Development concerning the provision of measurement devices for various purposes. Other interaction is with the Town Clerk, Public Works and Tax Collector in provision of measurement devices activities for various purposes.
  - (3) Other. The Weights and Measures Division interacts with community groups and agencies, private enterprises, state agencies and other municipalities to seek effective accomplishment of goals and objectives."
