

#### Town Council Meeting March 3, 2022



A quorum being duly present, President Matthew Levesque called the March 3, 2022, Town Council meeting to order at 7:10 PM.

An announcement was made by President Levesque regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 18.

The Pledge of Allegiance was led by Councilor Levesque. Vice President Paula Schnepp dedicated the moment of silence to the citizens of Ukraine whose lives have been upended into chaos and violence by the invasion of their country by the Russian military. She hoped for an end to the violence and a return to peace as soon as possible.

#### **PUBLIC COMMENT:**

Bettina Abe explained she had attended a webinar on Salt Marshes hosted by Mass Association of Conservation Commissioners and the Association to Preserve Cape Cod. The webinar affirmed the ecological reasons to preserve all 40 acres of the Twin Brooks Golf Course. She noted the need to conserve the land near the salt marsh as the non-static nature of salt marshes themselves. She hoped the Council would allow the salt marsh area to expand and grow.

Timothy Regan from Housing Assistance Corporation urged Council to prioritize housing and move forward with the Local Comprehensive Plan (LCP).

Betty Ludtke spoke about town owned properties and questioned their usage. She felt the Amory building could be better utilized as a children's museum. She hoped for more housing on Main Street and was happy to hear the Cascade Motel had sold may be there could be a partnership with the new owners to ensure more housing.

Cheryl Powell spoke in favor of applicant Thomas Doherty for the Hyannis Main Street Waterfront Historic District Commission. She asked that he be recognized as a full member as the position was open at this time.

Roberta Mauch said there was a group gathering the needed signatures to hold a public meeting. She urged Council to accept the public meeting to be held at the Barnstable High School. The concerns were the high density and the need to make the best decisions for Barnstable. She felt not all voices are being heard.

Devan Bollinder urged Council to ensure there was affordable available housing in the LCP. He was concerned with what Cape Cod will look like in the future.

#### **Response to Public Comment:**

(Clark) Supported the idea to utilize under occupied or unoccupied buildings as possible housing properties. There could be an incentive to convert properties to housing. (Hebert) Coordinated approach for housing with a housing complex which would be 100 percent affordability. Affordability means rent should be based on 30 percent of a person's income.

- LCP Elizabeth Jenkins, Director of Planning and Development provided and update on the LCP. She noted they had received 54 applications for the Local Comprehensive Plan Committee, with all seven villages represented.

#### **Councilor Questions and Comments:**

(Hebert) Thanked Councilor Jen Cullum for all her hard work on leading the application process for the Appointments Committee.

(Ells) Described the applicant process for the LCP Committee. The Town Manager selects the LCP Committee not the Appointments' Committee. He reached out to the Chair of the Appointments' Committee to help benefit the selection process. Both Councilors Jessica Rapp Grassetti and Jen Cullum have been very helpful. The LCP plan needs to be certified by the Cape Cod Commission. Pleased to hear we have 54 applicants for the LCP Committee positions. Once the LCP Committee is created the Town Manager steps back and the LCP Committee will complete a draft of the LCP to be later approved by Council and certificated by Cape Cod Commission.

(Cullum) Thank you for the thoughtful approach and outreach.

Karen Nober, Town Attorney gave the rationale. She discussed this was to designate members of the Local Comprehensive Planning Committee as special municipal employees. She explained in recognition of the fact that when you have unpaid volunteers who serve on a board you want to make certain provisions of law less restrictive to encourage one to serve on a board and not be restricted in their ability to earn a living. She noted this would update the language and bring it consistent with how the Town treats the other board and committee members.
