

Town Council Meeting December 12, 2024

A quorum being duly present, Vice-President Craig Tamash called the December 12, 2024, Town Council meeting to order at 6:00 PM.

An announcement was made by Vice President Tamash regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 8 or Channel 1072.

Councilor Clark introduced veteran, Ned Dashner to lead the pledge of allegiance, followed by Vice-President Tamash with a moment of silence for the memory of Tom Mullen.

PUBLIC COMMENT:

In-Person:

Rick Brigham asked to please elect a Council President that will listen to the residents of this town. Better a slow smart decision. Why are we still working with Avangrid? He said, "John Crow stated You gave away our voice and our leverage," referring to Matt Levesque. Will these resident beaches become unusable. Is Goliath intimidating you? Vote for a Council President that will support the residents.

Carlos Barbosa be more clear in regards to the zoning. If you are going to change the zoning, I am going to go elsewhere. He supports Matt Levesque for President.

In Person:

COUNCIL RESPONSE TO PUBLIC COMMENT:

(Schnepp) the grant funding that we are in the process of receiving and is part of the Town Manager Report. (Neary) regardless of who this Council elects, it is a lot of work, when you look at the breath and scope of the town. Being in the leadership position you become a target, what we do not want is to have a fractured Council. Let's listen to both sides of the story, more

conversation on both sides of an issue. (Levesque) thanked everyone for the comments. My daughter is also here. I was accused of being a flip flopper, If you look at the Capital Improvement Plan (CIP) the recreational area and parking was asked for by the public, longer term plan for the rest of the property. Toxic environment on the council. Service over self. (Tamash) Thanked everyone who came to speak, participation by the public is essential.

Discussion:

(Tamash) there are a lot of major items in your report, could you speak to the Executive Office of Energy and Environmental Affairs' especially regarding Article 97 (Ells) Legal department identified this, it wasn't obvious, they were looking for a change, legal is taking it under review. We need to comment on this and have a united response as a Council. (Nober) these regulations passed in 2022 PLPA the change of use of land protected by Article 97. No net loss policy, to ensure that when land is protected by Article 97, any change of use, there would be no net loss. We are reviewing the regulations, can participate remotely. We have time to review the regulations until January 22nd. (Schnepp) could you speak to the grant on item number 4 what are the contingencies (Ells) that is money that may be awarded, there are conditions that must be satisfied to keep all or part of the money. Related to renewable energy, there is one other community eligible. Sean Hogan did an outstanding job in securing the funds. (Schnepp) do you anticipate that a change in our national level could have an effect on this (Ells) yes, lots of speculation. (Levesque) important to complement Sean Hogan on the work that he has done to secure this grant. Also, to Councilor Starr for pursuing this staff position. (Clark) Sean Hogan has brought to the town many more financial dollars to benefit the town. Brian Taylor, harbormaster, received the 2024 Boaters Choice Award.

2025-049 FISCAL YEAR 2025 SPENDING LIMITATION FOR ASSET MANAGEMENT REVOLVING FUND INTRO: 11/21/2024, 12/12/2024

Mark Milne, Director of Finance, gave the rationale.

Discussion:

(Clark) If an opportunity arises in a certain amount of time a revolving fund would be prudent thing to do. Healthy to have a funding source so the town can be responsive to opportunities. (Schnepp) Having flexibility to spend funds on potential acquisitions is important, we do have other funding sources. My concern is it will be unlimited, up to the balance we currently have. I think the 2nd option would be prudent; (\$62,000) we are always able to provide additional money if necessary. (Ells) Whenever we enter into a contract there are multiple steps involved, the accountability is built in. Director Milne would be involved and ultimately, I would sign the contract. (Starr) who makes the final decision (Ells) I am responsible for everything the staff does; I sign the contracts. We track everything the same way. (Starr) support the 62,000, for this year (Crow) this money is for land acquisition only or is there anything else (Ells) the Town Council created this, but anything additional we will ask Director Milne (Milne) for the support and promotion of any asset of the town. Which includes title searches, appraisals, 21E investigation, those that you typically incur procedurally. (Crow) does that include buying and selling property or other things, products (Ells) no just real property (Neary) the Asset Management group since 2018, sold off small lots of that had to go through title searches, cannot imagine there would be outrageous bills, I think it should stay with Asset Management (Crow) is this money invested in any way, if so what are the returns on this money (Milne) we are getting investment return, per the state that goes to our General Fund.

(Schnepp) Upon a motion duly made and seconded it was to amend the item to \$62,000 for the remainder of FY2025 and to release \$100, 000 in FY2026 and in FY2027

(Milne) suggest we do this just for the 2025 fiscal year for \$62,000 and bring this back to the council in the next year's budget.

(Schnepp) Withdrew the motion and (Neary) withdrew the second.

(Schnepp) Upon a motion duly made and seconded it was to amend the item to authorize \$62,000 for the remainder of FY2025 for the Asset Management Revolving Fund.

Discussion:

(Ludtke) I will not support this (Clark) given the information from Director Milne, this money can remain until the AD Hoc committee has made some traction (Penn) Will not support the amendment. (Schnepp) these Asset Management funds will probably be used for due diligence, I would like to be fully briefed on how money is going to be spent (Levesque) any expenditure should be discussed and decide how we spend it (Crow) are we given any forward knowledge on how this money is spent? (Crow) will Asset Management have to come back to the Council before the money is spent. (Ells) you are assigning that to me, as long as it is within the amount of money you have voted on, no. I will keep you advised, but no you don't have a vote on it, unless you put a restriction on it. We can't buy land. (Levesque) could it be expended for outside legal counsel, does that fall within the funds (Milne) Yes it would. (Terkelsen) could you give us a couple of expenditures we have used (Milne) funds on appraisals, property management on the funds. (Anthony) Appraisals a low as \$800, some have approached \$4,000, disposing of the Cotuit School, all documents worked with a consultant, remove an underground oil tank. Studies of larger properties, to verify if it would be good for housing or something else. Flexibility is important. (Mendes) our responsibility is the financial stability of the town. Good amendment, they can always come to us if they need more money (Clark) Did we take a similar

vote to establish the revolving fund (Milne) Yes (Crow) there seems to be some confusion here maybe it is best if we wait for the Ad Hod Committee to get a handle on this.

On the amendment: Upon a motion duly made and seconded it was to amend the item to authorize \$62,000 for the remainder of FY2025 for the Asset Management Revolving Fund.

Discussion:

Councilor Neary spoke in favor of Matt Levesque. Councilor Starr asked the candidates how we get items on the agenda? (Tamash) just bring it up at the Agenda meetings (Levesque) just ask, we need a discussion on the dais. (Starr) opportunities missed this year, we never got to the strategic plan; the training of new Councilors; Flow neutral; Green communities; specific housing coordinator. Councilor Schnepp commended candidates for taking up this role. What are your priorities for 2025? (Tamash) two things, Councilor training, important that new councilors have standardized training, including meeting with staff like a mini town academy. The strategic plan has been put off and that must be a January project. The rates for TIE and TIF need to be addressed and reevaluated. Wind is not going away, form based zoning will need to be addressed by the full council. (Levesque) open to review of all zoning, form based was to allow a fourth story more affordable housing; short term rentals are there corporations coming in to buy up homes and change them to shore term. Housing production plan, where are we? Home ownership for younger people; environmental issues; housing bond bill; restore a good relationship with the Cape Cod Commission. Homeless crisis, opioid is moving forward, working with school issues, the Brazilian Community.
