V. OLD BUSINESS:

The Town Manager had a public hearing on the proposed marina/mooring regulation changes last Friday. The changes and comments from the hearing are with the Town Manager for review and acceptance.

VI. NEW BUSINESS:

Cape Marine Contracting request for a commercial mooring was tabled as no one was there to represent them.

Request by MRW Marine Services was presented by Mr. White and discussed by the board for a commercial mooring permit near Cotuit Town Dock. Mooring would be for servicing, testing and procedures for his vessel repair business. Would not be a permanent home to anything. Motion was made and seconded for the greater good to give Mr. White a mooring. And recommend the same to the Harbormaster. Carried unanimously.

Ordinance update to Chapter 40: (Boats) for concurrence with the Environmental Police. This would be done by adding to the waterskiing ordinance the wording "Additionally there shall be no water skiing within 300 feet of a shoreline being used as a swimming area whether public or private". The Cmte supported the proposed change.

VIII. HARBORMASTER REPORT:
