Waterways Committee Meeting April 25, 2017 Minutes

A meeting of the Town of Barnstable Waterways Committee was held on April 25, 2017 at Town Hall - Selectman's Conference Room. The meeting was called to order at 7:01 pm by Chairman Jack Meade.

ATONS are being placed in Town of Barnstable Waterways. Prince Cove Bulkhead project is currently underway. Anticipated finish date is May 1st, 2017. The Harbormasters office is busy getting ready for the summer season.

Matters Not Reasonably Anticipated by the Chair: Mr. Millard Hennessey and Mr. Murray were present and wished to discuss why a vessel could not be upgraded to 30' (ft) vessel. Mr. Millard and Mr. Murray stated they were unaware of a vessel restriction and mooring guidelines. This matter was deferred to Harbormaster Staff.
