Meeting Minutes:

Approval of June 27, 2017 meeting minutes. **Approved as written.**

Notice of Intent (NOI):

1. Bergeron, Jay & Crowley, Joanne L - 59 Short Beach Road, Centerville : Applicant is proposing to replace the existing concrete bulkhead with timber.

Harbormaster & Waterways Committee have no objection

2. Shah, Niraj & Jill M - 110 East Bay Road & 30 Gardiner Lane, Osterville : Applicant is proposing to install a new boardwalk, seasonal ramp and a floating dock.

Waterways Committee has concerns about plan presently presented due to boardwalk blocking access to upper reaches of marsh area. Waterways would like to see viable alternatives to the section of the boardwalk that passes over water.

3. Barr, Trustee Jan T - 0 Long Beach Road, Osterville : Applicant is proposing to construct a pier, boardwalk, ramp and a float.

4. Murphy, Jennifer R & Edmund F - 656 Sea View Ave, Osterville : Applicant is proposing to replace a 3 foot wide pier with a 4 foot wide pier, rotate existing ell 4 feet, relocate pilings and add a ramp and float.
