## Waterways Committee Meeting November 28, 2017 Minutes

A meeting of the Town of Barnstable Waterways Committee was held on November 28, 2017 Town Hall - Selectman's Conference Room. ### NOTICES OF INTENT (NOI):

1. *CAJ, LLC c/o Nicholas Gleysteen, Hellman, Jordan Management Co. 123 Seapuit River Road, Osterville, MA: Applicant is proposing to extend the existing pier, and to replace the existing ell with a ramp and float.*  
Harbormaster & Waterways Committee recommends the stand alone pile to be moved in from the channel so it is equal distance to the pier from the channel and the vessel's engines to be in line with the pier; when engines are up they should not protrude past the pier.
2. *Turner, David, 108 Bay Shore Road, Hyannis, MA: Applicant is proposing to stabilize an existing concrete block bulkhead with an approximately 72 foot wood bulkhead.* Harbormaster & Waterways Committee with no navigational issues had no objections

2. **Dredge funding ideas:** A summary of "Potential funding Sources for comprehensive Maintenance Dredging Program" was reviewed with the committee and a discussion followed as to who will take on this burden of 1.5 million dollars annually. No new ideas were gleaned, but the members will continue to think about options and ways to implement them. Meade strongly felt the burden should not fall just on the boaters of Barnstable.
