### Meeting Minutes:

Approval of July 24, 2018 meeting minutes. All meetings are recorded and available on line at Towns web site. Motion was made by Paul Everson to accept the minutes as written. It was seconded by Jack Meade.

### Notice of Intent (NOI):

1. Town of Barnstable, Conservation Department, 235 Cedar Tree Neck Road, Marstons Mills, MA 02648, Map 76, Parcel 24. The proposed project is to license a float reconfiguration, existing rock revetment, concrete ramp and Floating Upweller System (FLUPSY) .

2. Mitchell, Jill F.G., 345 Baxters Neck Road, Marston's Mills, MA 02648 Map 075/parcel 007 001; applicant proposes to install timber bulkhead in front of existing failing steel bulkhead.

The proposes project includes permitting of recently constructed stairs, and a proposed seasonal pier.

4. Crane, Melissa Fish, 218 Long Beach Road, Centerville, MA 02632; revised plans for an extension of float. Original NOI was for dredging.

**Harbormaster staff would like a vessel restriction on the float. We would recommend a MAX of 32 ft. in length and 9.5 ft. beam. Waterways agreed with Harbormaster staff.**

**Correspondence:** Pecks Maritime Collaborative; Laurie Opie spoke about changing the name of Pecks Boats to Pecks Maritime Collaborative. Waterways committee members present has no issue with a name change or any name change moving forward. No motion was needed.

**Harbor Master Report:** Harbormaster's Office permitted 86 new moorings so far this year. Assistant Mooring Officer Brian Taylor contacted approximately 200 people on the waiting list about new moorings. Harbormaster staff removed winter stakes and illegal moorings throughout the Town of Barnstable this past month. Identification of illegal moorings is sometimes difficult. Illegal mooring gear is auctioned off after a year.

**Adjournment:** There being no further business, a motion by Robert Hazelton to end the meeting was made. It was seconded by Paul Everson and the meeting adjourned at 7:38pm
