Harbor Master Report:

Harbormasters office is busy placing ATONS and Regulatory Buoys throughout the town of Barnstable. Harbormasters Office is approximately 95% done. Yesterday, May 21, 2018 we placed the regulatory buoys out in Wequaquet Lake. There is Transient dockage available at our Town Marinas. Mooring Officer has aggressively been offering moorings. Approximately, 88 letters were sent to previous mooring permit holders that did not renew in 2018. Mr. Everson asked about winter stakes and mentioned he has seen some and they can create a hazard to navigation. No wake buoys have been moved out to ATONS number 9 and 10 in Hyannis (Lewis Bay). Harbormaster staff was on scene during the weekend educating boaters and will continue to do so. Mr. Hazelton inquired about large Regulatory Buoys at numbers 9 and 10 to be more visible to boaters. Harbormaster staff will be looking into this in the future.
