Meeting Minutes:

The Waterways Committee voted by majority to approve December 17, 2019 minutes a motion was made by Peter Cross and seconded by Robert Hazelton.

Notice of Intent (NOI):

1. Remondi, John, 150 East Bay Road, Osterville, MA 02655 Map 140/Parcel 166. Applicant request to amend the Order of Conditions/SE3-5591 to allow the permitted dingy dock to remain in place year round. **No objections by Waterways Committee.**
2. Martirosian, Vahan & Rosemary, Trustees, Martirosian Realty Trust, 25 Sea View Ave, Osterville, MA 02655, Map 162/Parcel 026 011. The applicants propose to repair and improve the existing stone revetment and nourish the beach. **No objections by Waterways Committee.**
3. Liles Investment Partners, LLC, 40 & 50 Clamshell Point Lane, Cotuit, MA 02635, Map 006/Parcel 005 006. The applicant proposes to construct and maintain a bulkhead. **No objections by Waterways Committee.**

Mooring Appeals:

1. Lloyd, Wingate: Cotuit Outside: CTO/08 did not renew in 2019 (swim float). **My Lloyd was represented by Fred Stetson. Waterways Committee approved his request to renew.**

Old Business:

1. Hyannisport mooring field reconfiguration
Mr. Taylor stated mooring field reconfiguration is a 4 year 4 phase plan. Phase 1 should be completed by spring. Individuals within phase 1 were notified of new locations by email. Mr. Meade kindly reminded mooring permit holders of renewals for 2020.
2. Transient Mooring Lewis Bay/Cotuit Town Dock. **Mr. Taylor stated this should have also included Fish Hills. Mr. Taylor briefly described locations of a pilot transient mooring program the Town of Barnstable is rolling out.**

New Business:

1. Mooringinfo.com
Mr. Taylor discussed the new web based database for the Marine and Environmental Affairs Department. Anticipated date this new database will be rolled out is spring 2020. This program will serve the entire Department not just Harbormaster. Mr. Meade would like to see attachments added to this database such as excise tax, etc. for easy online renewals.
2. Dockwa.com
The Town of Barnstable has joined with Dockwa to advertise transient moorings. Dockwa seems to be the most prevalent program used in the Northeast. Mr. Taylor wanted the Town of Barnstable on the map for transient moorings and believes this is the best program to do so.
