# III. Notices of Intent (NOI):

- 1. Sidman, Lori, Trustee, 185 Ocean View Avenue, Cotuit, MA 02635, Map 033/ Parcel 016. The applicant proposes to repair, maintain and relocate pier head and boat lifts. Due to shoreline accretion, pier lifts will be adjusted 25 feet seaward; the pier will extend 60 feet from Mean High Water. *Continued to the next meeting*
- 2. JMS Holdings LLC, 134 South Bay Road, Osterville, MA 02635 Map93/Parcel 64. The applicant proposes to replace the existing pier, which is partially permanent and partially seasonal, with a permanent pile supported pier in the existing footprint. There will be no change to the existing 8 X 25' float and no change to the 3 X 14' ramp. Arlene Wilson of A.M. Wilson Associates, Inc. is representing this project and she will answer any questions. DH Horn stated the Harbormaster has no objections to this project is staying within the same foot print. Committee voted in favor of the project by roll call vote, Greg Egan in favor, Gary Shramek in favor, Peter Cross in favor.
