

 - Public Listening Session March 2014
 - Public provided input on what they wanted to see
 - Provided input on concerns
 - Traffic congestion
 - Lack of Pedestrian Amenities
 - Conflict between cars/pedestrians
 - Does not look like the rest of Main Street








Project Background

- Previous Work
 - Public Information Session June 2014
 - Presented some concepts to the Public based on Input from March 2014 Meeting
 - Improvements to the Center Street intersection (Roundabout Concept)
 - Helps ease Traffic congestion
 - More Pedestrian Amenities/Crosswalks
 - Break the Roadway into Three Distinct Sections for Roadway Landscape and Streetscape Treatments










Breaking the streetscape treatments along the corridor up into three distinct segments










Reasons to make Improvements to Zone 1 -Pedestrians Improve sidewalks width, curb height, and materials.

Enhance streetscape features and lighting
