NOTICE OF DOCUMENT AVAILABILITY

HYANNIS, MA – The Town of Barnstable Planning and Development Department (PDD) is issuing a **Substantial Amendment to its 2020-2025 Consolidated Plan and 2020 Annual Action Plan (AAP)** to reprogram unspent program year (PY) 2020 funds up to \$100,000 to public facility activities in program year 2022. This document is a federal requirement triggered when there is a fiscal change greater than twenty-five percent (25%) of the total annual CDBG Entitlement (\$286,135), per the Citizen Participation Plan (CPP). As referenced in CFR 24, Part 91.505, the Town will also officially amend its approved Consolidated Plan whenever it decides to pursue any of the following:

- To make a change in priorities or change the method of distribution of funds;
- To carry out an activity that does not address the goals described in the action plan; or
- To change an activity's purpose, scope, location, or beneficiaries.

This document serves as a planning document for the Town's CDBG Program, funded by the U.S. Department of Housing and Urban Development (HUD).
