## SANDY NECK BEACH PARK 2021 OFF ROAD VEHICLE (ORV) PERMIT AGREEMENT

Please attach the following **REOUIRED** Document(s) to this Application:

- Copy of valid vehicle registration (If vehicle is leased, please upload a copy of the front page of lease agreement.)
- Copy of valid driver's license

#### **BARNSTABLE RESIDENTS**

- Proof of Residency is established by the address shown on vehicle registration. Vehicle must be registered in your name (or the name of a person residing at your same address) unless there is: written permission to use a company vehicle, or proof of ownership of the company listed on the vehicle registration.
- If vehicle is NOT registered in the Town of Barnstable, a copy of a Town of Barnstable tax bill or a Year Round Residential Lease showing a Barnstable address must be included.
